

Terms and conditions “You can win this car in 2020” Campaign.

These terms and conditions refer to the over the counter campaign from January 13th till August 5th 2020

Article 1 Definitions

Customer	Customers who does a PuntoMio, Expresspost, MoneyGram or Road Tax 2020 transaction over the counter at Cpost International N.V. under their personal name. Company accounts are excluded.
over the counter raffle	Raffle organized by Cpost International N.V. in which Customers who do an over the counter transaction are eligible to win prizes.
Cpost Invoice	Payment of PuntoMio, Expresspost, MoneyGram and Road Tax 2020 transactions rendered at the counters of Cpost International N.V
Cpost Voucher	The Customer will receive a voucher with a number provided by Cpost International N.V. which has to be completed by the Customer
Raffle Closing Date	Raffle Closing date is August 5 th 2020, 17:00 PM.

Article 2 Entry requirements

2.1 Over the counter Raffle is open to all Customers except employees of Cpost International N.V. and Volkswagen Curaçao.

2.2 In order to participate:

For every PuntoMio, Expresspost, MoneyGram or Road Tax 2020 transaction, the Customer will receive a voucher to complete with his / her information and deposit it in the blue box.

2.3 The date of the Cpost transaction must be between January 14th and August 5th 2020.

2.4 Requirements per product.

- PuntoMio ; Every shipment paid for and picked up at our branches will eligible for one voucher.
- Expresspost: Every shipment sent and paid for at one our branches will be eligible for one voucher.
- MoneyGram: Every send or receive transaction at one of our branches will be eligible for one voucher.
- Road Tax 2020: Every Road Tax purchased (half year or full year) at one of our branches will be eligible for one voucher.

2.5 Validations per product.

Each winning voucher will be checked to see if it is valid. Transactions that are not complete or reversed or not within the campaign dates, will be disqualified.

- PuntoMio, Participating Airwaybill should belong to winning account. Paid at counter or via our self service Kiosk. Home delivery not valid for participation.
- Expresspost, Participating Airwaybill must have been processed at one of our counters and name on voucher must match name on file.
- MoneyGram, Participating Transaction number must have been generated at one of our branches and must match with name on voucher and may not have been reversed.
- Road Tax 2020, Name on voucher must be registered as owner of the car and transaction must have been done at one of our branches.

2.6 Failure to comply with any of these rules may result in the disqualification of the entry. Cpost International N.V. Reserves the right to disqualify any entry at their absolute discretion.

Article 3 Liability

3.1 In the event of an error, howsoever caused, whether a printing error or otherwise and whether obvious or otherwise, which affects the competition in any way, Cpost International N.V. reserves the right to administer the raffle as though the error had not occurred. Where the Cpost International N.V. deems it appropriate and/or feasible Cpost International N.V. will notify entrants of the error.

Article 4 Winners

4.1 The winners will be drawn randomly . Cpost International N.V. decision is final and no correspondence will be entered into. Prizes cannot be exchanged for cash.

4.3 The winners will be notified on the next working day after drawing, either by email or telephone.

4.4 The winners name will be announced on Cpost International's website and Facebook page.
