# Terms and conditions "Puntomio Campaign 2025"

These Terms and Conditions refer to the PuntoMio Campaign 2025. This campaign starts on June 6<sup>th</sup>, 2025 and ends on December 31<sup>st</sup>, 2025.

## **Article 1 Definitions**

Digital entry To be eligible for participation, customers must have a minimum of 10 delivered and

paid Airway Bills during the campaign period. Eligibility will be automatically

recorded upon receipt of payment for each participating Airway Bill.

The Raffle The raffle to be held on January 9th, 2026, based on delivered and paid Airway Bills

of Customers as per June 6th, 2025 up to December 31st 2025. The raffle will be held

by members of our Internal Audit Department.

#### **Article 2 Entry requirements**

- 2.1 The PuntoMio Campaign 2025 Raffle is open to all Customers, with the exception of employees of Cpost and Reshapers.
- 2.2 In order to participate in the Raffle, all packages (Airway Bills) that were delivered during the campaign period to the PuntoMio customers must have been paid by December 31st, 2026. To be eligible to participate, participants need a minimum of 10 delivered and paid Airway Bills during the campaign period. This will be automatically generated when payment of the Airway Bill is received.
- 2.3 Failure to comply with any of these rules may result in the disqualification of the entry.

#### **Article 3 Liability**

- 3.1 In the event of an error, howsoever caused, whether a printing error or otherwise and whether obvious or otherwise, which affects the Raffle in any negative way for Cpost or the Customer, Cpost reserves the right to cancel the Raffle and to organize a new Raffle, without liability towards Customer.
