

## **Terms and Conditions**

### **Pay your 2025 Road Tax and WIN it BACK!**

Automatically enter for a chance to get your full payment refunded!

These Terms and Conditions apply to the “Win Your Road Tax Back” Campaign, running from July 1st, 2025 to October 31st, 2025.

### **Article 1 – Definitions**

Customer:	Individuals who purchase Road Tax 2025 during the campaign starting July 1 <sup>st</sup> , 2025 to October 31 <sup>st</sup> , 2025 at Cpost International N.V.
Road Tax 2025 Raffle:	A raffle organized by Cpost International N.V. in which customers who purchase their 2025 Road Tax are eligible to win the amount that has been paid during the Campaign period.
Cpost Payment:	Payment of Road Tax 2025 made at the counters or kiosks of Cpost International N.V. in Punda and Groot Kwartier, or via bank transfer.
Raffle Closing Date:	October 31st, 2025 at 12:00 PM.

### **Article 2 – Entry Requirements**

2.1 The Road Tax 2025 Raffle is open to all customers, except employees of Cpost International N.V.

2.2 To participate, the customer must complete their Road Tax 2025 transaction at the counters or kiosks of Cpost International N.V. in Punda or Groot Kwartier, or via bank transfer.

2.3 The transaction must be completed between July 1st, 2025 and October 31st, 2025.

2.4 Failure to comply with these rules may result in disqualification. Cpost International N.V. reserves the right to disqualify any entry at its sole discretion.

### **Article 3 – Liability**

3.1 In the event of an error, howsoever caused, whether a printing error or otherwise and whether obvious or otherwise, which affects the competition in any way, Cpost International reserves the right to administer the raffle as though the error had not occurred. Where the Cpost International deems it appropriate and/or feasible Cpost International N.V. will notify entrants of the error.

#### **Article 4 – Winner**

4.1 The three winners will be selected at random on November 3rd, 2025.

4.2 The winners will be notified via phone.

4.3 Cpost will be authorized to make pictures of the prize award ceremony and make these available to the media. If a winner does not give his/her consent for any announcement on Social Media or pictures taken, he/she will not be eligible to win the prize. The prize will then be offered to the next eligible customer.

4.4 The winner's names will be announced on Cpost International's website and Social Media pages.

4.5 The winner authorizes Cpost International N.V. to take pictures of the prize award ceremony and make these available in the media.

4.6 If a winner does not claim their prize within 15 days of the draw, a new winner will be selected.

#### **Article 5 – Prize**

The prize for each winner consists of a full refund of the 2025 Road Tax amount that has been paid during the Campaign period.

#### **Article 6 – Modifications**

Cpost International N.V. reserves the right to amend, withdraw, or terminate the raffle, or alter its terms, at any time without prior notice.

#### **Article 7 – Governing Law**

This agreement is governed exclusively by the laws of Curaçao. Any disputes arising from this agreement will be submitted to the Court of First Instance of Curaçao.
